Regulation

The contest promoted by the Saslong Classic Club together with Dolomites Val Gardena is open to everyone. Excluded from the competition are the members of the jury as well as all those who collaborate in various capacities within the organization of the Ski World Cup in Val Gardena/Gröden. Participation is free of charge.
- To participate follow these three simple steps:
 1. Click "like" on the **Facebook** pages "[Val Gardena Gröden](#)" e "[FIS Alpine Ski World Cup Gardena Gröden](#)" or "follow" on **Instagram** [dolomitesvalgardena](#) and [skiworldcupvalgardena](#);
 2. Shoot your **video** or take your **picture** cheering from home while watching the Ski World Cup races in Val Gardena/Gröden. The men's super-G will take place on Friday 18 December at 11:45 am followed by the men's downhill on Saturday 19 December; and
 3. Send us the video/photo via [Facebook, Instagram](#) or e-mail to alexia.demez@saslong.org
- The material must be sent no later than **19 December at 3 pm** (CET).
- The jury is composed of 2 members of the Saslong Classic Club, 2 members of Dolomites Val Gardena and 1 accredited journalist. The Jury's evaluations will be based on the following parameters/concepts: creativity, originality, iconographic quality, fun. The final decision of the jury cannot be contested.

- The winners will be informed directly by the organization via e-mail and the photos will be published on the social media channels of the organizers.
- Each author, holder of all rights to his originals, is personally responsible for the works submitted. Each author retains the ownership of the images submitted to the contest, but gives the rights of unlimited use of the images free of charge to the organizers of the contest, who may publish, print and modify the material, without prior agreement with the participant.
- Participants are civilly and criminally responsible for their works, relieving the organizers from any responsibility, including with regards to any subjects depicted in the photographs/videos. The contestant must inform any interested parties (persons portrayed) in the cases and in the manner provided for in Article 13 of the European Regulation on the Protection of Personal Data EU 2016/679, and obtain consent to the dissemination of the same, under penalty of exclusion from the competition. Under no circumstances may the images submitted contain data that can be qualified as sensitive.
- Participation in the competition implies unconditional acceptance of the rules contained in this Regulation.
- Please note that in accordance with Article 13 of the European Regulation on the Protection of Personal Data EU 2016/679, the personal data provided by competitors, collected and processed by computer, will be used to identify the winners and to identify the authors of the photos/videos in the various occasions in which they will be exhibited or published and for communications relating to the competition itself. The competitor has the right to access the data concerning him/her and to exercise the rights of integration, rectification, cancellation etc. guaranteed by Article 13 of the aforementioned law, with regards to the data controller. The conferment of data and consent to its processing are necessary conditions for participation in the competition.
